

The Rockwood Area Board of School Directors met in regular session on Monday, April 19, 2010 at 7:30 P.M. in the Administrative Office of the Rockwood Area School District.

The financial and treasurer reports, bills, and budgetary transfers were approved as presented.

#### Public Comment:

Dan Cramer addressed the Board regarding the national day of silence in support of gays and lesbians or whatever support that was held on Friday. He was not in favor of allowing this to happen and believes that a letter should have been sent home to all parents prior to the event occurring. Mark Bower clarified that the protest activity was to protest hate speech activities directed towards gays, lesbians, and transgenders. Mark Bower also informed the public that it was not a school sponsored activity, but was student initiated. Mark Bower informed the public that other student led activities similar to this have occurred in the past and federal law allows this type of expression as long as the activity does not disrupt the educational process of the district.

### Old Business:

The board approved the implementation of a driver education program to be held during the summer of 2010 at an approximate cost of \$5,400.00 based on 30 participants.

The board approved amended policy number 201 (Admission of Students) with the corrected typographical errors.

Amended policies number 335, 435, and 535 (Family and Medical Leaves) were approved.

Amended policy number 605 (Tax Levy) was approved.

Amended policy number 808 (Food Services) was approved.

#### New Business:

The first reading of policy number 808.1 (Free/Reduced – Price Meals and Free Milk) was approved.

The EETT grant in the amount of \$50,000.00 was accepted.

The board voted to table the approval of the food service contract with Metz & Associates for the 2010-2011 school year at a breakeven profit/loss margin.

The Somerset County Technology Center secondary budget was approved for the 2010-2011 fiscal year.

The Somerset County Technology Center adult budget for the 2010-2011 fiscal year was approved.

The board accepted the donated equipment from WTAE 4 News for the district TV production club.

The board voted to adopt the Designation of Agent Resolution as required in order to be eligible for PEMA emergency snow removal funds.

The contract with CAMCO for physical and occupational services for the period August 1, 2010 through July 1, 2012 at the rate of \$53.00 per hour was approved.

The 2009-2010 school calendar was amended to include 6/14/10, 6/15/10, and 6/16/10 as snow make-up days and to set the graduation date on 6/16/10.

The board authorized the administration to begin the exploration process for the construction of a practice field.

Mark Bower informed the Board that the additional ARRA State Fiscal Stabilization Grant funds are already included in the ESBE amount for the district. These are not additional funds.

The Board discussed the installation of bleachers and fencing at the athletic facility. These will be discussion items at the budget meetings.
