

The Rockwood Area Board of School Directors held its regular monthly meeting on Tuesday, October 20, 2020.

The minutes of the committee meeting on 9/15/2020 and the regular meeting on 9/15/2020 were approved.

The Board approved the financial and treasurer reports, bills, and budgetary transfers as presented.

Old Business:

The Board discussed possible action on revisions to the Rockwood Area School District Health and Safety reopening plan. No changes were made to the plan.

The Board approved the following revision to the Rockwood Area School District Athletic Health and Safety Plan:

The Board initiated discussion and authorized a decrease in capacity at all athletic events from 50% capacity to 25% capacity to adhere to the Governor and Secretary of Health's guidelines.

New Business:

The Board approved the Field Placement Memorandum of Understanding between the Rockwood Area School District and Drexel University, beginning October 1, 2020, and continuing until written notice is given by the District.

The Board approved the final transportation rates and routes for the 2020-2021 school year.

The Board approved the proposal from Eastern Elevator Service & Sales Company in the amount of \$1,020.00 to perform the required five-year elevator safety test.

The Board approved the Schoolwide Title 1 School Plan for the 2020-2021 school year.

Superintendent's Report:

Mark Bower recognized and congratulated Vileska Gelpi on winning the PIAA Class AA Girls State Golf Championship.

Mark Bower provided the status of the fall sports: The Boys' Varsity Soccer Team is currently undefeated with a record of 15-0, the Girls' Varsity Soccer Team is currently in third place, the Varsity Volleyball Team has a record number of wins this year compared to past seasons and is in the running to make playoffs, and the JV and Varsity Football Teams are currently undefeated.

Mark Bower expressed his gratitude for being in the eighth week of in-person instruction and thanked the faculty and staff for their support thus far.

Mark Bower informed the Board that the Administration continues to plan for the possibility of remote learning. They continue to review the challenges being faced. Internet access for students has been a main challenge and obstacle. The Administration has been working with various organizations to discuss options that will allow students to gain access to internet services and "hot spots".

Mark Bower informed the Board that cyber school attendance has increased. There are approximately 20 students who enrolled into cyber schools at the beginning of the school year due to the current circumstances. The additional cost associated with increased enrollment could exceed our budget by \$250,000.00 to \$300,000.00.

Mark Bower informed the Board that the State released the Act 1 Index for the Rockwood Area School District for next year at 3%. At this point, the District does not see the need to raise taxes above the index. It is most likely a resolution will be prepared and adopted according to the Act 1 timeline, indicating the District will not raise taxes above the index.

Mark Bower shared with the Board an email received from another school district. A student athlete from another school district experienced an injury during a sporting event. The parent of the athlete expressed her appreciation to our coaching staff for handling the athlete's injury.
