

The Rockwood Area Board of School Directors met in regular session on Monday, April 18, 2011. The minutes of the committee meeting on 3/21/11 and the regular meeting on 3/21/11 were approved. The agenda, agenda items, and additional agenda items were also approved.

Upon discussion, the financial and treasurer reports, bills, and budgetary transfers were approved as presented with the exception of the invoice from Future Industries in the amount of \$2,704.86 which will be held until May or upon resolution of the coal specification issue.

#### **Old Business:**

President, Mark Phillippi, appointed Zach Gaskin to serve on the Rockwood Area School District Strategic Plan Committee.

The coal bid was awarded to Penn Keystone Coal Company, LLC for the 2011-2012 school year at a price of \$139.50 per ton.

The propane bid was awarded to Ferrellgas for the 2011-2012 school year, in the amount of \$1.899 per gallon.

The board approved the revision to policy number 601 (Fiscal Objectives) of the Rockwood Area School District Policy Manual.

The board approved the TremCare Service Agreement with TREMCO in the amount of \$6,688.00 per year for a period of five years with the option to renew on an annual basis.
