

The Rockwood Area Board of School Directors met in regular session on Monday, March 15, 2010 at 7:30 P.M. in the Administrative Office of the Rockwood Area School District.

The Rockwood Area junior-senior high speech team provided various types of speech presentations for the Board and public.

The minutes of the committee meeting on 2/15/10 and the regular meeting on 2/15/10 were approved.

The agenda and agenda items were approved as amended at the committee meeting.

The financial and treasurer reports, bills, and budgetary transfers were approved as presented.

Public Comment:

John Kreger asked the Board if any bids were received on the Kingwood building. Ron Saler informed him that the situation will be discussed under the Superintendent's report.

Old Business:

The board voted to reject the bids for the boiler modification project at the Rockwood Area School District and to pursue the possibility of completing the project in-house.

Superintendent's Report:

Mark Bower informed the Board that there were no bidders on the Kingwood School. There was a party that expressed some interest, but they felt that they needed more time to prepare for a bid.

James Harrold informed the Board that the space at Kingwood may still be needed in the future.

Mark Bower informed the Board that International Christian Aid is interested in some of our old desks and furniture.

Mark Bower informed the Board that the PSBA Spring Legislative meeting will be held on 4/7/10 at 7:00 P.M. in Windber. Interested Board members should contact Mark so that registrations can be made.

Mark Bower informed the Board that the snow has brought down the backstop at the baseball field. The district must immediately replace it for liability reasons and the funds will come from the maintenance budget.

The Board was informed that there are only nine individuals signed up for baseball, and only 5 are eligible at this time. The Board has given a deadline of Friday, March 19th for at least nine members to be eligible or there will be no team.

The board voted to waive the age restriction for two individuals to attend the prom.

General Board Member Discussion:

Allen Pletcher asked why there are more aides employed by the district now with over 100 less students. Mark Bower informed him that there are several required special education aides, which are paid for with IDEA funds. There is also an aide that covers the library saving the district funds by not employing 2 librarians.

Ron Saler expressed his appreciation for the forensic presentation and has asked that a letter be sent to the organization on behalf of the Board.

Ron Saler has requested that a sick leave report be made a part of the monthly Board packets.

The meeting adjourned at 12:30 A.M.
