

The Rockwood Area Board of School Directors met in regular session on Tuesday, August 16, 2016

The minutes of the committee meeting on 6/21/16 and the regular meeting on 6/21/16 were approved.

The agenda, agenda items, and additional agenda items were approved.

The financial and treasurer reports and bills were approved.

Public Comment:

Several football players, playing under the cooperative sports agreement, addressed the Board, thanking them for approving the cooperative agreement and providing transportation to Berlin for games and practices. They feel the experience has been very positive, and they have been treated equally with the Berlin athletes. They asked the Board why transportation would not be provided on Saturday for the scrimmage game. The administration will look into the issue, as they were not aware that transportation would not be provided.

Barb Drake addressed the Board about safety concerns on transportation route #2; especially the crossing of both lanes for pick-up and drop-off of students as a result of the change in the route made for the 2015-2016 school year. Brian Coughenour informed Mrs. Drake that a recommendation on the route will be made as part of the next agenda item.

Old Business:

The Board approved the recommendation by Brian Coughenour, transportation director, to change transportation route #2 for the 2016-2017 school year, which will allow the students on Route 653 to enter and exit the bus on the same side of the road as their residence.

Mark Bower informed the Board that the paving project has been completed. The final inspection with Somerset Planning will occur on Thursday, August 18, 2016 at 9:00 A.M.

Mark Bower informed the Board that the stumps by the elementary playground have been removed, and the area has been seeded and drainage has been installed.

Mark Bower informed the Board that the grant for the tennis courts through DCED has been denied and the deadline for submission for this year has passed. The District is planning on applying for another grant next year.

Mark Bower passed out elementary and high school staff and enrollment information to the Board members. He also distributed a copy of the high school master schedule to Board members.

Mark Bower informed the Board that the district received approximately \$79,000.00 additional state funding with the passage of the state budget.

Mark Bower informed the Board that the administration will begin doing Board briefs at the end of the first week of school.

Mark Bower informed the Board that Betsy Smith was recognized by Metz Culinary Management over the summer for 15 years of service.

Mark Bower thanked the administration and support staff for their efforts over the summer in preparing the district for the start of school.
