

The Rockwood Area Board of School Directors met in regular session on Tuesday, August 18, 2015.

The minutes of the committee meeting on 6/30/15 and the regular meeting on 6/30/15 were approved.

The agenda, agenda items, and additional agenda items were approved.

The financial and treasurer reports, bills, and budgetary transfers were approved.

Public Comment:

Students from the French Exchange Program presented a power point presentation on their recent trip to France.

Old Business:

The Board approved the second and final reading of policy number 819 (Suicide Awareness, Prevention and Response) of the Rockwood Area School District policy manual.

The Board voted in favor to discontinue pursuing a guaranteed energy savings project with Johnson Controls.

New Business:

The Board approved the transportation driver list and substitutes for the 2015-2016 school year pending completion of all paperwork.

The Board approved the contract with KSL Group for the 2016-2017 funding year.

The Board approved the letter of agreement with The Learning Lamp for Title I services for the 2015-2016 school year.

Superintendent's Report:

Mark Bower presented a power point presentation to the Board on the Raise.Me scholarship program opportunity through Penn State University. Rockwood was one of five schools to receive this pilot program in Appalachia IU 08.

Mark Bower informed the Board that the auditorium project is almost complete and should be ready for the start of school.

Mark Bower informed the Board that the desks are scheduled to be shipped this week. In the event that they do not arrive for the start of school, the district has made schedule arrangements.

Mark Bower informed the Board that the new table for the Board room should be completed by the end of this month and in place by the September board meeting.

Mark Bower reviewed the current participation figures for the fall sports.

Discussion was held to authorize the district to move forward with the junior high golf program with a minimum of four participants and to pursue securing a coach for the program.

Mark Bower reviewed the recent PSSA scores and expressed his concerns over the results. He is very pleased with the academic structure of our district and believes the scores have fallen significantly as a result of changing the test to meet the common core standards.

Mark Bower informed the Board that there is a leak in the roof above the cafeteria serving line. The roof is under warranty and the company has been contacted.

Mark Bower informed the Board that four of our seniors have been invited to attend the 9/11 Memorial dedication on 9/10/15 and will be a part of the program.

General Board Member Discussion:

The Board approved a non-resident tuition waiver for the student of an employee beginning with the 2015-2016 school year.
