

The Rockwood Area Board of School Directors held its annual reorganization meeting on Tuesday, December 8, 2015.

The minutes of the committee meeting on 11/17/15 and the regular meeting on 11/17/15 were approved.

The agenda, agenda items, and the additional agenda items were approved.

The financial and treasurer reports were approved.

Old Business:

Mark Phillippi gave the oath of office to newly elected Board members: Shannon Berkey, Irvin Kimmel,Jr. and Noah Wareham.

Mark Phillippi appointed Clair Saylor as temporary chairperson to preside over the meeting.

Mark Phillippi was elected to the office of President by a vote of the Board.

Jason Coho was elected to the office of Vice-President by acclamation.
