

The Rockwood Area Board of School Directors met in regular session on Tuesday, August 19, 2014.

The minutes of the committee meeting on 7/15/14 and the regular meeting on 7/15/14 were approved.

The agenda and agenda items were approved.

The financial and treasurer reports and bills were approved as presented.

## **Public Comment:**

Fran Brancato addressed the Board regarding the future of the football program at Rockwood. He realizes the program did not meet the requirements established by the Board and expressed his support for a cooperative arrangement for next year. He would like the Board to consider other options for the remainder of this season, such as practicing until the start of school to see if more participants are available for the program.

#### **New Business:**

The Board decided to add a discussion regarding the future of the football program as an item to the agenda under old business. Upon discussion, the board voted to cancel the junior high and junior varsity games for the 2014-2015 school year, authorize the coaches and athletes to use the facilities for the remainder of the year for practice and conditioning, and authorize the administration to purse a cooperative sports agreement with the Somerset Area School District in the areas of football, cross-country and track.

The tentative transportation drivers and substitutes for the 2014-2015 school year were approved.

The agreement with Clapper Educational Consulting for community resource consultation for the 2014-2015 school year was approved.

The contract with Champion Christian School for transportation services for the 2014-2015 through 2018-2019 school years was approved.

The contract with The Meadows Universal Community Behavior Health for the 2014-2015 school year was approved.

The board voted in favor of the Rockwood students to run cross-country independently with the Somerset Area School District at no cost to the district, unless the student qualifies for post season competition.

The board approved the elementary reading and mathematics curriculum for the 2014-2015 school year.

The board approved the athletic schedules for the 2014-2015 school year.

The board approved the Somerset County Nurses' association meetings for Amanda Custer for the 2014-2015 school year.

The board accepted the quote from ASCC for the replacement of the PA system.

# **Superintendent Report:**

Mark Bower informed the Board that the district will continue to line the athletic field for the pee wee football program if the Board has no objections.

Mark Bower informed the Board that the PA system is scheduled to be installed on 8/28/14 if the order comes in. The district has purchased air horns in the event of a lock down until the system is in place.

The kindergarten class is at 46 at the present time with the possibility of 3 more students. If the number grows to 50 or more, the administration may be back to the Board for consideration to add an additional class.

Mark Bower informed the Board that the roof is scheduled to be completed by 8/26/14.

Mark Bower shared a letter from the ministerium requesting that the district refrain from scheduling events at the school on Sunday mornings.
