

The Rockwood Area Board of School Directors met in regular session on Tuesday, February 17, 2015.

The minutes of the committee meeting on 1/20/15 and the regular meeting on 1/20/15 were approved.

The agenda and agenda items were approved.

The financial and treasurer reports, bills, and budgetary transfers were approved.

Old Business:

The Board approved the Memorandum of Understanding with Johnson Controls in developing a business case analysis that projects the financial benefits of a guaranteed energy and operating savings program.

New Business:

The Board approved hosting the ATOMS program from June 24, 2015 through June 26, 2015.

The Board approved the annual agreement with ASCC for the Vodavi telephone system in the amount of \$3,765.00.

The Board approved the annual donation in the amount of \$100.00 to the Somerset County Reading Teacher's Association for the annual Scrabble tournament.

The Board approved a three year contract with Kotzan CPA & Associates for district auditing services.

The Board approved the contract with Hoover Brothers Quality Painting in the amount of \$9,473.41 for painting the underside of the corrugated metal roof.

The Board voted in favor of consideration to approve a junior high golf program – minimum of 5 athletes.

The Board voted in favor of consideration to approve a junior high track program – minimum of 12 athletes.

The Board approved the renewal contract with Metz for the 2015-2016 school year.

The Board approved the cooperative agreement with Berlin Brothersvalley School District for football.

Superintendent's Report:

Mary Gosnell updated the Board on the Shred It program being conducted by the life skills students in the district.

Mark Bower passed out an article honoring Sharon Clapper as being recognized as one of the top 100 business people of central Pennsylvania.

Mark Bower informed the Board that junior high fun night will be held on 2/20/15, weather permitting.

Mark Bower informed the Board that an active shooter drill was held as part of the Act 80 day on Monday.

The district discussed the future of the ice rink. Mark Bower informed the Board that the Merchants Association is no longer in existence and they are looking for someone to take over the liability of the rink. The district liability insurance will cover the rink for the remainder of this year but a cost of between \$50.00 and \$100.00 may be required in future years. The Board will discuss this issue at a later date.

Mark Bower thanked the Board for their support on approving the junior high track, golf, and football cooperative agreement, providing more opportunities for district students.

General Board Member Discussion:

The Board discussed the engineering proposals received for the proposed district paving project. The proposals range from \$14,000.00 to \$50,000.00. The proposals will be reviewed and a recommendation will be presented at the March meeting.
