Superintendent's Report:

Mark Bower updated the Board on the construction of an area on the tennis court for the storage of salt and anti-skid. The concrete barriers will cost approximately \$3,200.00; and to cover the facility would cost an additional \$7,000.00. The Board will discuss this item during budget meetings.

Mark Bower informed the Board that the dishwasher motor has been repaired at a cost of \$241.00. This is only a Band-Aid solution and upgrading the cafeteria will be discussed as part of the needs assessment.

Mark Bower updated the Board on cost estimates that he has received for the possible upgrade of our athletic facilities. The design and various required approvals would cost approximately \$40,000.00 to \$50,000.00, and the preparation of the bid documents and the oversight of the project would be an additional \$65,000.00. Once again, this item will be discussed at budget meetings and as part of the needs assessment.

Mark Bower discussed the training requirements for newly elected Board members and those that have been recently re-elected. He gave them several options, ranging from going out of the district to classes or taking the on-line course.
